The Supreme Council has changed the meeting requirements for all councils. New guidelines were published to reflect what Knights want and need today to improve meeting experience and to respect members' time.

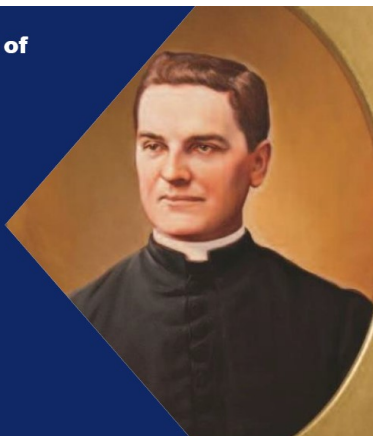
- Two monthly meetings are required: a **Leadership Planning Meeting** and a **Membership Meeting**.\*

⇒ **“Welcome home”** to brother Jim Rispoli after his lengthy stay in Morristown Memorial hospital!

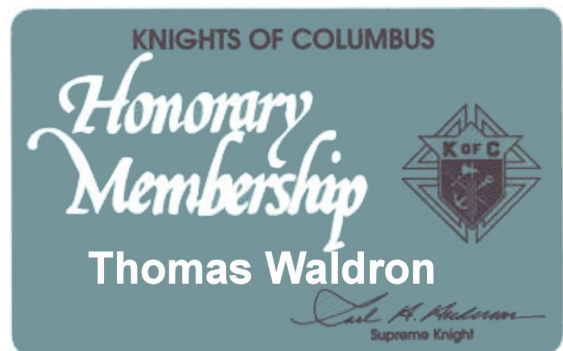
⇒ **Good luck and good health** to brother Dean Rapp and wife Fran with their relocation to Delaware!

## Knights Continue Flag Project with Scouts, Scouts Seek Needy People to Help

The last quarter of 2020 saw the Knights of this council continue to work with Scouts BSA Troop 121 of Clinton to maintain the flags displayed on overpasses over Interstate 78 and Route 31. One torn flag was replaced at the overpass by Cryan's Tavern in Annandale, and at the time of this newsletter's publication one flag from the Potterstown Road overpass was taken down to replace the ropes that keep it on place. It will be displayed again before January 1.

Currently, I am co-teaching the *Ad Altare Dei* religious emblem program to Scouts in Hunterdon County on behalf of the Diocese of Metuchen.

Each Scout must participate in five service projects. One of those projects (associated with the Sacrament of Anointing of the Sick) involves assisting an elderly or infirmed person. ## Book Review: Irreversible Damage

“...since parents have conferred life on their children, they have a most solemn obligation to educate their offspring. Hence, parents must be acknowledged as the first and foremost educators of their children.” -*Gravissimum educationis*, 3. (Second Vatican Council)

“Even parents that come in and say, ‘I don’t want my [daughter] to be called [a boy’s name].’ That’s nice, but their parental right ended when those children were enrolled in public school.” -5<sup>th</sup> grade teacher C. Scott Miller to Abigail Shrier, in an interview

From time to time, crazes – a cultural enthusiasm that spreads like a virus – occur. The effects of such crazes range from neutral to negative, but parents need to be concerned when such crazes include, encourage, or glorify self-harm because of the susceptibility of youth (having little or no experience to discern the ultimate effects) to latch on to a craze. Adolescent girls, as a group, have shown particular vulnerability to crazes spread through peer contagion that involve self-harm (e.g. bulimia, anorexia, cutting, etc.).

What sets transgenderism apart from previous crazes is that it is being created by and fueled through relatively new technology, schools, state legislatures, and all facets of today’s health care system. Its possible effects, even on youth who take medication for the short-term, include delay in brain development, endocrine system failure, and permanent sterility. Long-term effects and complications are too gruesome to be listed here.

Prior to 2013, gender dysphoria was a very rare condition that primarily affected males. The expected incidence was about one in ten thousand males, and in pediatric cases approximately 70% of those resolved without serious intervention. The expected incidence in females was dramatically less, perhaps two or three in a hundred thousand females. By 2017, the CDC was reporting rates of transgenderism in US high schools at two per one hundred students, indicating an increase of between 200 and 600 times the expected amount. The vast majority of this new surge are adolescent girls who, according to their parents, have never exhibited any of the clinical symptoms of gender dysphoria prior to self-diagnosing themselves.

The author shows that the origin for their self-diagnosis is usually by being exposed to gender theory at school with reinforcement through friend and social groups, or through social media such as Facebook, Instagram, and YouTube. Gender theory (as opposed to the truth of a person’s innate biological sex) is introduced as part of anti-bullying programs at elementary-, middle-, and secondary-school levels, usually through materials provided by, developed by, or strongly influenced by homosexual/queer lobbying groups. Social media “influencers” distribute positive messaging that identifying and taking action as a transgender person is a risk-free activity and that self-diagnosis can definitively be made based solely on the youth’s feelings at that time.

Commonly, the first indication to a parent that something is going on is a period of doing poorly in school or with personal relationships. This is followed by change in appearance (adopting a boy’s hairstyle or clothing choices), and then a demand by the youth to be referred to by a different name and entirely new pronouns (he/him instead of she/her). Once the parents’ jaws are lifted from the floor, their most common step is to contact a therapist.

Parents will be greatly surprised by something known as the “affirmative-care” standard adopted by most therapists at the behest of almost every medical professional society. This means that the therapist, rather than evaluating the patient and making a professional diagnosis will accept the self-diagnosis of a youth as Gospel truth, setting the stage for escalating issues. The harm induced by such a therapist is virtually incalculable.

In the meantime, the youth will have received accolades and support from online and in-person groups celebrating their stance. This attention serves to paint the youth in a corner, but also grow to increasingly isolate the youth from their parents. Such online groups serve to provide advice on how to convincingly lie to parents and medical professionals, and obtain sex-change devices and drugs from facilities on an “informed consent” basis – many times without a doctor’s referral, evaluation by a local therapist, or parent’s permission. As any trained volunteer who works with youth on behalf of the Church could predict, such online groups are crawling with pedophiles and others with ill intents. The cult-like behavior within this movement is noteworthy and has had a chilling effect on reporting on the subject both in scientific, technical, and popular writing. School policies, often reflecting policies in state law or the state’s Department of Education, will likely hide children’s behavior from their parents.

*Irreversible Damage* (by Abigail Shrier, 2020, Regnery Publishing) should be the most important book of the year for parents, grandparents, Catholic teachers and catechists, and all those who work with youth on a paid or volunteer basis. For parents, this book offers lessons learned from other parents on how to try to prevent your daughter (or son) from being swept up in this craze, important information on how to react if they are, and also after-the-fact guidance if steps have been taken by the parents, the child, or others to move them down this path. The primary audience is parents of daughters. This book is ABSOLUTELY NOT for youth. The author uses a number of anecdotes and experiences that are not for the faint of heart. It is a difficult read due to the emotional and sometimes explicit physical material presented, knowing that so many youth have been harmed in this way.

It is important to note that this book is written from a secular basis, without reference to religion. This was a conscious decision by the author in order to reach a maximum audience. Regardless, the distinction between a Catholic education tethered to Scripture and Tradition, and public or secular private education guided by the whims of this world couldn’t be clearer. This book is a strong reminder to parents to ask questions about anti-bullying materials being presented at their current or prospective school, since parents can opt-out their children from sexual education, but not anti-bullying programs.

Importantly, the author makes a clear distinction between those who legitimately have this serious disorder and those who are compassionately providing medical care, and those who are caught up in the craze and those who are profiting off of their self-harm. Given the actual cause of their mental distress may go completely ignored for years or decades, those “professionals” and others involved are culpable for shattering the bodies, minds, and families of thousands and thousands of youth, including some in our area. That so many public and private institutions continue to drive the conditions needed to sustain this craze in the name of diversity and inclusion and anti-bullying, in the reviewer’s opinion it is unlikely to subside in the near future.
